# Senior Director for Access and Delivery at the Global Health Innovative Technology (GHIT) Fund

Dr Isaac T. Chikwanha is Senior Director for Access and Delivery at the Global Health Innovative Technology (GHIT) Fund. He has more than 20 years' experience as a clinician, public health specialist and in the 7 years, an advocate for equitable access to medicines. Prior to joining GHIT, he worked with Médecins Sans Frontiers (MSF) for nearly a decade in numerous countries, first as a frontline field doctor and then in various project management positions, including 2 years working on Access to Medicines at the MSF Access Campaign.



Isaac started his medical career in 1997 as a general medical practitioner with a special interest working with underprivileged communities in his native Zimbabwe. He holds a Bachelor of Medicine and Surgery (MB,ChB) degree from the University of Zimbabwe and a Master's in Public Health (MPH) from the University of Sheffield School of Health and Related Research in the United Kingdom.

Ngozi is also the Health Security co-editor for the PLOS Global Health academic journal.






#### **Dr Béatrice Greco**

Retired Director of the Department of Control of Neglected Tropical Diseases, World Health Organization, Geneva, Switzerland

Dr Dirk Engels is a Global Health Consultant and Senior Adviser to Uniting to Combat NTDs (www.combatntds.org). He has worked for the World Health Organization in Geneva for 20 years and retired as Director of the Department of Control of Neglected Tropical Diseases (NTDs) at the end of 2017. In WHO, he has worked on infectious and tropical diseases. He has been instrumental in developing norms and standards for the large-scale implementation of NTD interventions, in developing the first NTD roadmap with a focus on elimination, and in steering the global expansion of interventions for the control and elimination of tropical diseases. During the first half of his professional career he successively





worked in clinical tropical medicine, public health, and disease control, in East, Central and West Africa. Dirk Engels is a medical doctor, and holds additional diplomas in tropical medicine and hygiene, epidemiology, a master's degree in health services research, and a PhD in parasitology. He has published over 100 peer-reviewed scientific and public health papers.

## **Vice President, Public Affairs**

Sam is the Vice President, Public Affairs at the END Fund. He is responsible for the organization's global external engagement, including advocacy and communications that advance the neglected tropical disease (NTD) platform and attract additional resources and attention to the NTD sector. Sam leads the END Fund's efforts to mobilize a growing ecosystem of NTD champions across governments, the pharmaceutical industry, and a coalition of other cultural, private sector, and community-based organizations.



Previously, Sam was Executive Director, International Programs at the M·A·C AIDS Fund where he oversaw a grant portfolio that supported 130 HIV/AIDS service organizations across 50 countries. There, he devised public private partnerships and strategic health programs that reached over 26 million people affected by or at risk of HIV/AIDS.

Prior to that, Sam led global fundraising efforts for a leading sport-for-development organization, Grassroot Soccer. He was also previously Chief Operating Officer for Millennium Promise, and Global Operations Manager at the Clinton Health Access Initiative where he helped establish the organization's health financing division.

He holds a Master's degree in Development Economics from the University of London's School of Oriental and African Studies, and a BA in Economics from the University of Strathclyde in his native Scotland.
